Thank you for taking the time to assist us with the correction of the change of ownership resolution. Your expertise and knowledge have been very helpful, and we are grateful.

Dr. Steven Bailey is the current owner and was also previously an Authorized User on the same license, and the two of you have since spoken several times on the phone. I, Laura Speer Smith, agree we are in violation of 10 CFR 30.34(b). To be clear we had sent in the attached document dated August 2018 via fax. From this point forward – I Laura Speer Smith will follow up on every information notice submitted. I, Laura Speer Smith, do want to additionally clarify, Dr. Bailey was performing actions based upon my advice to him, and therefore I do not believe he should be held directly accountable as he was using my consulting advice as his radiation expert and radiation safety officer. I, Laura Speer Smith, directly apologize for this fault and violation.

We therefore are submitting information directly as you requested to meet the NUREG 1556 vol 7, Rev 1 requirements.


- We agree we will submit an application for a license renewal at least 30 days before the expiration date.
- We have attached a form 313 and this letter request an amendment.
- We submit our license number: 21-26539-01 Docket number: 030-33367
- Our Radioactive materials possessed remain the same under the new owner (Dr. Steven Bailey, DVM) as the previous owner (Dan Marshall, DVM).
- Our radioactive materials are used in the same safe manner, as previously.
- All materials are still, as always, properly handled and secured, all staff since the business sale remains the same, therefore have the same capable competency and are still committed to implement appropriate radiological controls.
- Our business still has adequate financial assurance to provide for full compliance with the applicable NRC requirements.

- Our chain of custody is clear in that Dr. Bailey is the owner and authorized user, each site has at least one overseer onsite who is a DVM and who is an Authorized User. The Radiation Safety Officer is Laura Speer Smith who provides guidance on regulations and safety to all sites within this license and she is overseen by Ray Carlson.
- The transferee has the financial resources to decommission the license, if necessary and it will be performed at no fees to the licensee as a guarantee by Laura Speer Smith as long as she remains the site RSO.
- Public health and safety are not compromised by the use of radioactive materials.
- We will reference this guidance document for all required future documents, including appendix D.

This business is already sold to Dr. Steven Bailey and this is our now formal notification after the fact, but for the record. We also wish to request to change the name formally to: Cats Radioiodine Treatment Centers, P.C.


