SUBJECT: SUMMARY OF A PUBLIC MEETING WITH SOUTHERN NUCLEAR  
OPERATING COMPANY ON MARCH 28, 2019

The U.S. Nuclear Regulatory Commission (NRC) staff held a Category 1 public meeting with Southern Nuclear Operating Company (SNC) on March 28, 2019. The purpose of the meeting was to discuss issues associated with the Uncompleted Inspection, Test, Analysis, and Acceptance Criteria (ITAAC) Notification (UIN), Item 2.2.02.07f.i [Index No. 145] for SNC's Vogtle Electric Generating Plant (VEGP) Units 3 and 4.

Summary of Meeting:

On March 28, 2019, staff from the NRC conducted a public meeting with representatives from SNC to discuss issues associated with the proposed testing methodology for SNC's VEGP Units 3 and 4 Notice of Uncompleted ITAAC for Item 2.2.02.07f.i, ITAAC Index No. 145. The staff had commented on the notice, and SNC requested a meeting to explain its approach to completing the ITAAC.

SNC briefed their presentation (ADAMS Accession No. ML19084A139) to the staff, and the staff asked clarifying questions about SNC's approach for the test, which involves measuring water delivery rates between the passive containment cooling system ancillary water storage tank, the passive containment cooling system water storage tank, and the spent fuel pool. SNC's approach for completing the ITAAC divided the test into two flowpaths, each with two segments and sharing a common point, and performing the test of each flowpath at different times to support the construction schedule and equipment availability issues. Detailed information about the testing configuration was provided in the briefing.

The staff commented that including the figures from the presentation in the UIN for this ITAAC would provide clarity to support the ITAAC closure. SNC agreed to follow up with the staff about whether additional information would be formally submitted to support the UIN.

At the conclusion of the meeting, there was an opportunity for the public to provide comments and ask questions. There were no comments or questions from the public.

Note: Subsequent to the meeting, SNC informed the staff it would resubmit the UIN with the additional figures.
