This refers to your license amendment request dated January 21, 2019. Please find enclosed Amendment No. 42 adding the renovated nuclear medicine department as a location of use and storage and removing the old hot lab and mobile van. In addition, Dr. Sivagnaman was removed from the license as an authorized user, per your request.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
