SUBJECT: SUMMARY OF PUBLIC MEETING

The U.S. Nuclear Regulatory Commission (NRC) staff met with the public on March 26, 2019, at 6:00 p.m., at Hotel 1620 in Plymouth, MA, to discuss the NRC's assessment of safety performance of the Pilgrim Nuclear Power Station (Pilgrim) during the 2018 calendar year. The NRC presented its assessment of the safety performance of Pilgrim for calendar year 2018, and specifically discussed the basis for transitioning Pilgrim from Column 4 of the NRC's Action Matrix to Column 1 of the NRC's Action Matrix as of March 4, 2019. The staff then conducted a question and answer session.
