On April 30, 2019, from 6:00 p.m. to 7:00 p.m. (EDT), a public outreach was held by representatives of the U.S. Nuclear Regulatory Commission (NRC) to provide the public with information on the 2018 End-of-Cycle plant performance assessment of the Fermi Power Plant, Unit 2, and with general information on the NRC. The open house was held at the Monroe County Commissioners' Chamber in Monroe, Michigan. The NRC representatives discussed plant performance with members of the public and a number of state employees. Representative from DTE Energy were also present at the event.

The NRC discussed their assessment of Fermi Power Plant, Unit 2's performance during the public outreach. The assessment information was documented in the March 4, 2019, End-of-Cycle Assessment Letter (ADAMS Accession Number ML19063B541). Representatives from the NRC made copies of the above letter and other brochures and fact sheets available to the public in attendance. Throughout the open house, members of the public were given the opportunity to ask questions of DTE officials.
