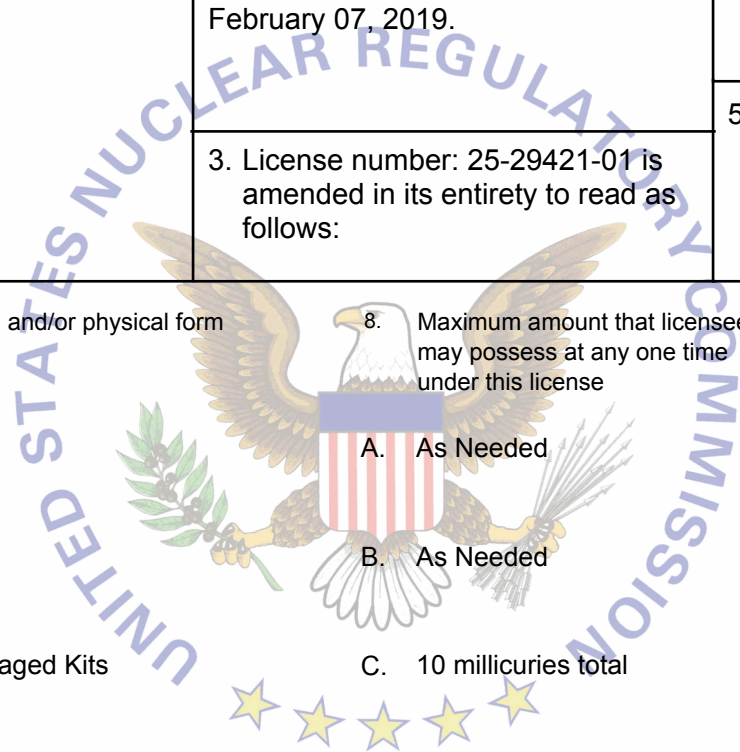


MATERIALS LICENSE

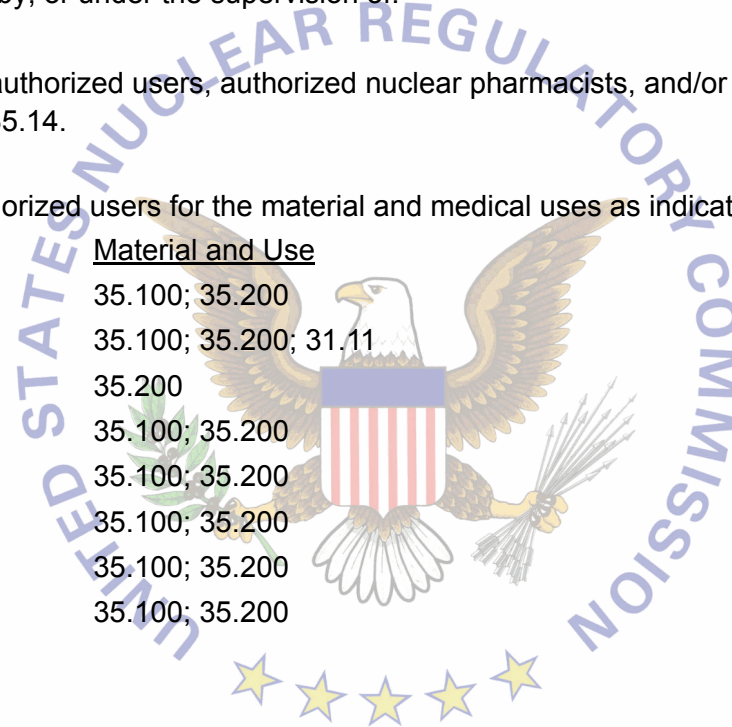
