SUBJECT: SUMMARY OF PUBLIC MEETING

On April 24, 2019, the U.S. Nuclear Regulatory Commission (NRC) conducted a public meeting at the Best Western Plus, The Inn at Hampton in Hampton, New Hampshire. During the meeting, NRC staff presented the Agency's assessment of the safety performance at Seabrook Station for the period of January 1 through December 31, 2018. The meeting also included a representative from the Federal Emergency Management Agency that discussed their role regarding emergency preparedness for Seabrook. The meeting presentation is an enclosure to this meeting summary and can be accessed from the NRC's Agencywide Documents Access and Management System (ADAMS) under Accession No. ML19130A137.

Members of the public, state and local officials, elected officials or their staff, and members of the media, participated in the meeting. The staff heard public statements and responded to inquiries regarding NextEra's performance, the role of the agency in ensuring safe plant operations, NextEra's licensing amendment regarding alkali-silica reaction, license renewal, emergency preparedness, climate change and nuclear waste. NRC staff placed documents received from members of the public at the meeting into ADAMS as a public record (ML19130A142) and staff also placed meeting feedback received into the NRC's Public Meeting Feedback System.
