A community engagement panel has not been established. Our periodic outreach to the Town, Counties, etc. leads us to continue to conclude that such a panel is not being pushed for by the community or the State. On the topic of economics, Dominion settled a property tax lawsuit with the Town and County in 2017, with an agreement that runs through tax year 2026.

Our outreach to the community consists of more informal drop-ins with the Town (occasional board meetings, or to discuss work

activities here, such as taking down the training building – aside – this activity requires a permit from the Town, so they know about it anyway, but we attempt to engage them). Also in the EP area we reach out to the counties periodically. Same with Fire Protection with the Kewaunee Fire Department and Security with the Sheriff. As well as RP with the State.
