SUMMARY: (Continued from page 1)

1. In your submittal, you requested to remove the Ohmart Model SH- 100 gauges from your license. To remove these gauges you must provide the following documentation:

- a. A list (including the serial numbers) of all of the Ohmart Model SH- 100 gauges that you have possessed under your license
- b. Documentation of the final leak test results for each of the gauges
- c. Records of transfer for each of the gauges to an authorized entity
- d. In your cover letter, please include a discussion of the historical leak test data for the Ohmart Model SH- 100 gauges (have you ever had a leaking gauge at your facility?)

2. Due to the requirements of our new licensing process, items 6-9 on your license will be listed in a different format going forward. Specifically, the devices currently authorized in Item 9.A.- 9.D. of your license may need to be formatted with separate authorizations, each with their own possession limit, in accordance with the Sealed Source and Device Registry.

To help facilitate this change on your license, please provide the following information for each device to be authorized:

- a. Isotope
- b. Device Manufacturer
- c. Device Model
- d. Maximum activity for any single source and number of gauges requested
- e. Total activity requested for devices of this manufacturer and model
- f. If a specific sealed source is used for any of these devices please include the manufacturer and model number of the sealed source
