The U.S. Nuclear Regulatory Commission (NRC) has issued for public comment a draft site-specific Supplemental Environmental Impact Statement (SEIS) to its "Generic Environmental Impact Statement for License Renewal of Nuclear Plants," NUREG-1437, regarding the subsequent renewal of Turkey Point Nuclear Generating Unit Nos. 3 and 4.
