Please clarify the following issues related to the company name and address.

1. You listed the name of the company as "Performance Materials NA, Inc., The Dow Chemical Company". When this license was requested, the name was listed as "Performance Materials NA, Inc". In addition, it was explained in the change of control action that is currently open, that the three new companies were subsidiaries of the combined Dow DuPont, not Dow Chemical Company. Because the NRC has a regulation which requires notification and approval prior to a change of control [10 CFR 30.34(b)], it is important that we are clear on who is the

responsible licensee. At this time, we believe that Performance Materials NA, Inc. is the responsible licensee. If that is not correct, please let us know.
