Notification of Name Change for Dow AgroSciences, LLC Broad Scope Materials License No. 13-26398-01


The Dow Chemical Company and E.I. du Pont de Nemours merged to form DowDuPont on November 1, 2018. All subsidiaries continued to operate under their heritage companies as realignment started with the goal of emerging as 3 independent and publicly traded companies: Dow, DuPont, and Corteva Agriscience. On June 3, 2019 Corteva Agriscience will complete the merger and spin activities and emerge on its own, no longer under DowDuPont. Dow AgroSciences will continue to be a legal entity under the corporate structure of Corteva Agriscience. Both sites under license number 13-26398-01 will continue to operate under all conditions listed in the license. The name of each facility will be changed to Corteva Agriscience. Additionally, emails will be switched over to the @corteva.com listed below in my electronic signature. See Attachment I for a chronological chart of the merger and spin activities.
