Dear Mr. Larson:

This refers to an investigation conducted by the U.S. Nuclear Regulatory Commission's (NRC's) Office of Investigations regarding activities at the Grand Gulf Nuclear Station. The Office of Investigations initiated the investigation to determine whether employees at the Grand Gulf Nuclear Station willfully failed to implement As Low As Reasonably Achievable (ALARA) planning and controls during Refueling Outage 20 (RF-20).

Based on the evidence developed during the investigation, the concern was not substantiated. The NRC plans no further action related to the willful aspect of this concern and considers this investigation closed.
