On April 18, 2019, the U.S. Nuclear Regulatory Commission (NRC) completed an inspection at your Palisades Nuclear Plant, Unit 1. On April 24, 2019, the NRC inspector discussed the results of this inspection with you and other members of your staff. The results of this inspection are documented in the enclosed report.

One NRC-identified finding of very-low security significance (Green) is documented in this report. This finding involved a violation of NRC requirements. The NRC is treating this violation as a Non-Cited Violation (NCV) consistent with Section 2.3.2.a of the Enforcement Policy.

If you contest the violation or significance or severity of the violation documented in this inspection report, you should provide a response within 30 days of the date of this inspection report, with the basis for your denial, to the U.S. Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington, DC 20555-0001; with copies to the Regional Administrator, Region III; the Director, Office of Enforcement; and the NRC resident inspector at Palisades Nuclear Plant.

One cross-cutting aspect was assigned to the above finding in the area of Human Performance – Procedure Adherence. Specifically, because your staff failed to follow processes, procedures, and work instructions. [H.8]
