Dear Mr. Sena:

The Region I Field Office, NRC Office of Investigations (OI), initiated an investigation (Case No. 1-2018-008) on January 23, 2018, to determine whether a supervisor deliberately failed to follow licensee procedures pertaining to the repair of a Salem Nuclear Generating Station service water pump; a supervisor directed subordinates to perform unauthorized work and/or falsify required records for the service water pump; and whether PSEG Maintenance and Repair Services management attempted to falsify and/or destroy records regarding work performed to the service water pump. Based upon documentary and testimonial evidence developed during the OI investigation, the NRC did not substantiate the aforementioned concerns.

Please note that final NRC investigation documents, such as the OI report described above, may be made available to the public under the Freedom of Information Act (FOIA) subject to redaction of information appropriate under the FOIA.
