Your request for information on May 22 to the Fees Help Desk regarding 1) the amendment of the Prime Processing Inc license, and 2) the renewal of the Mid-Vol Coal license was referred to me today. The Region I office performs all licensing and inspection activities of these licenses.

As you know, there was a problem with the in-processing of the one letter that was submitted to support both these actions. The in-processing was recently completed, and the actions were released this week to the Commercial, Industrial, R&D and Academic (CIRDA) Branch staff in the NRC Region I office, as available work. We have a goal for completing amendment actions within 90 days, and renewal of licenses within 180 days. At this time, neither action has been assigned to a staff member for review, although we expect that to occur soon.

The amendment action for Prime Processing was assigned Control No. 612217, and the renewal for Mid-Vol Coal was assigned Control No. 612269. The control numbers are unique to each licensing action, and you should refer to the control number in any correspondence related to that action. A new control number is assigned the next time you request a licensing action. The license number and docket number will remain the same.

There are several issues that are raised by the submission, because several of the documents, and your email address, refer to Arcelor Mittal. It appears that there may have been a transfer of control or ownership of the companies. It also appears that there may be a relationship between Mid-Vol Coal and Prime Processing. Such transfers are required under 10 CFR 30.34(b) to be approved by the NRC prior to transfer of the licensed activities to a new entity. <https://www.nrc.gov/reading-rm/doc-collections/cfr/part030/part030-0034.html> You should review the guidance in NUREG -1556, Volume 15 <https://www.nrc.gov/reading-rm/doc-collections/nuregs/staff/sr1556/v15/> and submit the information described in Chapter 5 and Appendix E for both licenses.

It is my understanding that a check was submitted with the letter requesting to amend the Prime Processing License and renew the Mid-Vol Coal license. Amendments and renewals do not require a fee be submitted. If the check was required in payment of an annual fee or a fine, no further action is necessary. If the check was not required, you should contact

Kelly Riner in the Fees office to determine how to obtain a refund or credit the amount to your annual fees.

A copy of this email will be placed in the file for each of the above licensing actions, so that whichever staff member is assigned to the action will be aware of the issues above.
