PROGRAMS TECHNICAL INFORMATION EXCHANGE PUBLIC
MEETING

On May 21-22, 2019, the U.S. Nuclear Regulatory Commission (NRC) met with representatives from the nuclear industry for an exchange of technical information on the industry's ongoing materials programs, in particular as related to the integrity of reactor pressure vessels, reactor vessel internals, and piping. The industry representatives included staff from the Electric Power Research Institute (EPRI), the Pressurized Water Reactor (PWR) Owners Group (PWROG), the Boiling Water Reactor (BWR) Owners Group (BWROG), licensees and vendor companies. Many of the licensee representatives also hold advisory roles to the EPRI Materials Reliability Program (MRP), EPRI BWR Vessel and Internals Project (BWRVIP), PWROG Materials Committee (MSC), EPRI Welding Repair and Technology Program (WRTC) and EPRI International Materials Research (IMR) committee. In addition, members of the public participated by teleconference.
