This refers to your license amendment request dated April 26, 2019. Please find enclosed Amendment No. 43 adding Andrew Boyer, M.D. as an authorized user and Radiation Safety Officer. Please note that Dr. Boyer was not authorized for oral administration of I-131 sodium iodide in quantities greater than 33 millicuries because your current license only authorizes use of I-131 sodium iodide in quantities less than or equal to 33 millicuries.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC. This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking Your License as specified in the NRC Enforcement Policy. 
