Dear Mr. Wheatley;

This letter is in regards to you letter dated May 10, 2019 requesting to add Yuri E. Peterkin, M.D. to License No. 55-17986-01 as an authorized user for byproduct materials permitted by 10 CFR 35.100, 35.200, 35.392, and 35.394. As stated in Robert Gallagher's e-mail dated February 13, 2019, changes to the language used by the American Board of Radiology (ABR) on the ABR certificates from 2017 forward have prevented the NRC from accepting these certificates as proof of training and education. The NRC is currently working with the ABR to resolve the wording issues, but until there is resolution of this issue, we are not able to accept Dr. Peterkin's Board Certificate.

In the interim, you must use the alternate pathway to demonstrate training and experience including a preceptor attestation for use of byproduct materials for 10 CFR 35.100, 35.200, 35.392, and 35.394. I have reviewed the 313A(AUD) and 313A(AUT) that you submitted. There are additional sections that will need to be completed, to be specific:

313A(AUD), Part I Training and Experience, Section 3.a. and b. in its entirety;

313A(AUD) Part II Preceptor Attestation – This section is completed correctly. However, since additional information will be added to the document, the preceptor will need to re-review the information from Section 3.a. and b. and resign the document;

313A(AUT), Part I Training and Experience, Section 3.a. and 3.b. (pages 2 and 3). The table in Section 3.c. is adequately addressed on the provided forms, but you will need to complete the top of page 4, which is a continuation of Section 3.c.;

313A(AUD) Part II Preceptor Attestation – This section is completed correctly. However, since additional information will be added to the document, the preceptor will need to re-review the information in the revised 313A(AUT) and resign the document.

Finally, we will need a copy of the most recent Winthrop University Hospital license listing Anca Kranz, M.D. and Wei Wen Song, M.D. as authorized users.

In order to continue prompt review of your application, we request that you submit your response to this letter within 30 calendar days from the date of this e-mail. If you have any questions, you may contact me at 610-337-5272 or by e-mail (preferred).
