Dear Mr. Gallagher:

This letter serves as written notice of the reorganization of the Trinity Health system of which St. Francis Hospital, Inc. ("St. Francis") is a part. The reorganization will occur effective as of July 1, 2019 (the "Effective Date"). In connection therewith, as of the Effective Date, the sole member of St. Francis will change from Trinity Health Corporation ("Trinity Health") to a subsidiary of Trinity Health, Mercy Health System of Southeastern Pennsylvania, which, as of the Effective Date, will change its name to Trinity Health of the Mid-Atlantic Region ("Trinity Mid-Atlantic"). This constitutes a change of control transaction as to St. Francis.

St. Francis is a Delaware nonprofit, membership corporation that has been recognized by the Internal Revenue Service ("IRS") to be a charitable organization described in Section 501(c)(3) of the Internal Revenue Code (the "Code"). St. Francis owns and operates a licensed acute care hospital located at 701 N. Clayton Street, Wilmington, DE 19805 and holds the above-referenced materials license.

Currently, St. Francis's sole member is Trinity Health. Trinity Health is an Indiana nonprofit corporation with an address of 20555 Victor Parkway, Livonia, MI 48152. It has been recognized by the IRS to be a charitable organization described in Section 501(c)(3) of the Code. Trinity Health is the parent of a large, multi-state, Catholic, nonprofit health care system.

As of the Effective Date, Trinity Mid-Atlantic, whose sole member is Trinity Health, will become the sole member of St. Francis. Trinity Mid-Atlantic is a Pennsylvania nonprofit corporation with an address of 1201 Langhorne – Newtown Road, Langhorne, PA 19047. It has been recognized by the IRS to be a charitable organization described in Section 501(c)(3) of the Code. Trinity Mid-Atlantic provides oversight and support for numerous nonprofit health care entities serving a number of diverse communities in southeastern Pennsylvania.

Upon the Effective Date, St. Francis will continue to offer the same services in connection with the above-referenced materials license. The legal name of St. Francis will not change in connection with this reorganization. Upon the Effective Date, there will be no changes in the radiation safety officer and authorized users, who were previously identified as such on the license referenced above. Additionally, upon the Effective Date, there will be no changes in the duties, personnel, location, facilities, equipment, or procedures that relate to the licensed program.
