This refers to your license amendment request dated May 21, 2019. Please find enclosed Amendment No. 52, which adds License Condition 21.C. regarding changes in your facility and areas of radioactive materials use.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
