Thanks for speaking with me yesterday, and confirming that the letter dated May 20, 2019, may be public without any changes.

I have gone through the information you submitted, and have a few additional questions:

1. Do you know if INEOS Neal LLC is a wholly-owned subsidiary of INEOS Enterprises? I don't see anything on the INEOS Enterprises web site that mentions INEOS Neal LLC. I need to state the relationship between INEOS Enterprises and INEOS Neal in our approval documentation.
2. Do you know if INEOS Neal LLC or INEOS Enterprises currently holds an NRC or Agreement State license at this time? I did find some NRC records that INEOS was a registered user of gauges under a general license until 2014. However, I need to know if they hold a current specific or general license somewhere in the USA. If not, I will need to gather additional information from them, and perhaps meet with the management representatives who will be managing activities at the Neal Plant. If you do not know the answers to these first two questions, please provide me with a name and contact information so I can ask these questions of INEOS directly.
3. Please confirm that the transaction date has changed to July 31, 2019 as you stated yesterday, or provide updated information for the date of transfer.
