## SUBJECT: FINAL ENVIRONMENTAL ASSESSMENT FOR THE PROPOSED AMENDMENT OF THE U.S. ARMY'S SOURCE MATERIAL LICENSE FOR THE JEFFERSON PROVING GROUND (DOCKET NUMBER: 40-8838)

Dear Ms. Thomas:

The U.S. Nuclear Regulatory Commission (NRC) is reviewing a request by the U.S. Department of the Army (Army) to amend the Army's source material license (SUB-1435) from "possession-only for decommissioning" to "possession-only" and to exempt the Army from the NRC's decommissioning timeliness requirements in Title 10 of the *Code of Federal Regulations* 40.42(d). The license currently authorizes possession-only for decommissioning of up to 80,000 kilograms (176,370 pounds) of depleted uranium metal, alloy, and/or other forms, kept onsite in a restricted area known as the "Depleted Uranium Impact Area" at the Jefferson Proving Ground in southeastern Indiana. If the NRC grants the amendment and the exemption requests, the NRC staff anticipates establishing a license condition that would exempt the Army from the need to submit a decommissioning plan for 20 years, at which time the Army would be required to submit a license amendment request and provide a basis for continuing the exemption.

As part of its review, the NRC staff prepared a draft environmental assessment (EA) and draft finding of no significant impact, which were published for a 30-day public comment period beginning February 4, 2019 (see *Federal Register* notice 84 FR 1522, dated February 4, 2019). The NRC staff reviewed the public comments on the draft EA and prepared the final EA, which includes an appendix that summarizes and responds to the comments we received on the draft EA. A copy of the final EA is enclosed.
