As we discussed, our office has reviewed the March 8, 2019 request from Daniel Polsky, BWGS, LLC, to terminate the referenced NRC radioactive materials license authorizing receipt and possession of krypton-85 sealed sources in lamps.

I have provided the request for additional information in the attached NRC Form 699, "Conversation Record." As noted, the requested information is based on information requested in the NRC Form 314, "Certificate of Disposition of Materials," as required by Title 10 of the Code of Federal Regulations Section 30.36(j).
