Dear Mr. Gadziala:

This message is a follow-up to our conversation yesterday.

The Change of Ownership for Hot Shots Nuclear Medicine and CPI Pharmacy Services was removed from the public website on Wednesday, May 8th. The NRC received no notice of comments, and our office will be proceeding with completing the action – confirming NRC consent to the Transfer of Control. We will let you know – by email or by phone – whether anything else is needed to complete our review, in order to issue our formal written consent to the transaction.

Please note that, because the transferee (Pharmalogic) is an existing NRC licensee, with authorizations for the use of byproduct material that are similar to those that CPI and Hot Shots are authorized for, we do not anticipate any showstopping issues that would interfere with the action going through.

If the transaction is finalized prior to the NRC's issuance of our formal consent letter, please notify our office promptly, in writing, within 30 days of the transaction. Please include a signed copy of the acquisition agreement, confirming completion of the transaction, with your letter. With this confirmation, we may issue an administrative amendment to your NRC license to reflect the transaction, if necessary.

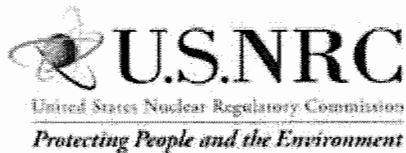

Dear Mr. Gadziala:

I am writing to confirm that we have reviewed the package submitted in support of requesting consent for NRC consent to Transfer of Control. At this time, it does not appear that we will need any additional information to complete our review. However, because the request must be posted to the NRC public website for at least 30 days, prior to us issuing our consent, we may not be able to issue our formal written consent and evaluation prior to the anticipated closing on 4/30/2019. If no comments are received prior to the close of the 30-day comment period, there should be no problem with your proceeding as planned, even if the formal consent is not issued. We will let you know if that happens. However, it is very unusual for our office to receive public comments on such a high-level indirect transfer of control; we are not expecting any such comments.

If you could resubmit your letter with your inquiry, and information concerning your points of contact, that is appreciated. You may submit the letter signed and dated as a pdf file, attached to an email.
