Control:

Control of the USNRC Radioactive materials license will be Saint Francis Medical Center, Cape Girardeau, MO. Saint Francis Medical Center is a not-for-profit health care facility incorporated in the State of Missouri and licensed by the State of Missouri to provide health care services. The hospital is accredited, where necessary, by various professional organizations including The Joint Commission.

Saint Francis Medical Center has a traditional line of authority composed of a Board of Directors that delegates authority to the Chief Executive Officer. The Chief Executive Officer has delegated the radiation safety aspects of its USNRC Radioactive materials license to a qualified Radiation Safety Officer.

It is the intention of Saint Francis Medical Center to transfer the licensed nuclear medicine activities currently covered under the USNRC Radioactive materials license held by Black River Medical Center to its USNRC Radioactive materials license.
