The revised RAI response has a section stating the impact of the response on the application, for both the Technical Specifications (TS) and the Updated Final Safety Analysis Report (UFSAR), indicating which sections, tables, figures, or drawings have been changed. Enclosure 4 provides a listing of CoC 1042 Amendment 1 TS minor editorial changes providing clarification and consistency. Enclosure 5 provides a list of TS pages changed by this Amendment 1 Revision 6 submittal. Enclosure 6 provides a complete revision to the TS, denoted as Amendment 1 Application, Revision 6.

Enclosure 7 provides Framatome document FS1-0044738, Revision 2, titled Fuel Assembly Cobalt Levels. This reference document is in support of the revised RAI 6-11 response. Since Enclosure 7 content is entirely proprietary, no public version is provided.

For the TS, Amendment 1 changes on Revision 6 pages are indicated by italicized text, revision bars, and gray shading to distinguish them from the changes proposed in Revisions 0, 1, 2, 3 and 5 of the Amendment 1 application. Revision 4 to the application was the resubmittal of a computer hard drive containing a file related to RAI 4-6.

Certain portions of this submittal include proprietary information, which may not be used for any purpose other than to support the NRC staff's review of the application. In accordance with 10 CFR 2.390, Enclosure 1 provides two affidavits specifically requesting that this proprietary information be withheld from public disclosure.
