Dear Mr. VanDyke:

This refers to your license amendment request dated May 28, 2019. Please find enclosed Amendment No. 13 authorizing a change in the management representative (Corporate Radiation Safety Officer) and the Radiation Safety Officer named in Condition No. 12 of License Number 47-16933-02. Also, the license reviewer determined that the address of the location of use was changed by the U.S. Postal Service to 810 Koppers Road, Follansbee, West Virginia (License Condition 10) and that you no longer possess KayRay Sensall or Nuclear Chicago gauges (License Conditions 7 and 9).

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC. This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking Your License as specified in the NRC Enforcement Policy. 
