This refers to your license amendment request dated June 4, 2019. Please find enclosed Amendment No. 2 authorizing the possession of up to six portable nuclear moisture/density gauges as discussed during our telephone conversation on July 17, 2019.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
