By letter dated February 26, 2018 (Reference 1, L-2018-048), Florida Power & Light submitted the 2017 Annual Radioactive Effluent Release Report for St. Lucie Units 1 and 2 pursuant to 10 CFR 50.36a(a)(2) and Technical Specification (TS) 6.9.1.7. The 2017 report provided information for the 12-month period beginning January 1, 2017 and ending December 31, 2017.

L-2018-048, Enclosure 1, Table 3.2, Solid Waste Storage and Shipments, Page 2 included a mathematical error. The sum of radiological waste stream Curies Shipped value was conservatively reported higher than actual. The reported value was within the +25% report error criteria and is attributed to a mathematical error. The enclosures of this letter provide the corrected page
