Pursuant to the National Environmental Policy Act of 1969 and the regulations of the Commission in Appendix D to 10 CFR Part 50, Metropolitan Edison Company, Jersey Central Power & Light Company, and Pennsylvania Electric Company have jointly filed the Environmental Report Supplement 2, Operating License Stage, dated February 28, 1975 in support of their application to operate the Three Mile Island Nuclear Station, Unit 2, located in Londonderry Township, Dauphin County, Pennsylvania. Notice of receipt of the application was published in the <u>Federal Register</u> on May 28, 1974 (39 F.R. 18497). Notice of availability of the applicants' Environmental Report dated December 10, 1971 was published in the <u>Federal</u>. <u>Register</u> on June 24, 1972.

The Environmental Report Supplement 2, Operating License Stage, updates the discussion of environmental considerations related to the operation of the proposed facility set forth in the Environmental Report dated December 10, 1971, as amended, and indicates the results of ongoing monitoring programs. Upon preparation of the draft environmental statement, the Commission will, among other things, cause to be published in the <u>Federal Register</u> a summary notice of availability of the draft statement, with a request for comments from interested persons on the draft statement. The summary notice will also contain a statement to the effect that comments of Federal agencies and State and local officials will be made available when received. The draft environmental statement will focus on any matters which differ from those previously discussed in the Final Environmental Statement dated December, 1972. Upon consideration of comments submitted with respect to the draft environmental statement, the staff will prepare a final environmental statement, the availability of which will be published in the Federal Register.
