The above-referenced letter advised Portland General Electric Company that changes in the organization structure described in Section 1.0, Organization, of PGE-8003 which do not adversely affect the Nuclear Projects Quality Assurance Program for Design, Construction, and Preoperational Testing are to be submitted to the U. S. Nuclear Regulatory Commission no later than 30 days after announcement.

Portland General Electric has notified the Nuclear Regulatory Commission of several changes in its organizational structure and indicated that they would be incorporated into PGE-8003 with the next technical revision.

Draft PGE-8003, Revision 3, has been prepared and incorporates the above changes as well as two additional organizational structure changes. Due to delays in issuing Revision 3 of PGE-8003 for your review, we are sending this letter to advise you of these additional organizational changes.

On June 18, 1979, the following reorganization will be effective:


