Dear Mr. Johnson:

This is in further response to your letter dated May 2, 1979 in which you requested, pursuant to the Freedom of Information Act, six categories of documents.

The NRC has been unable to locate any information pertaining to items 4a and 4b. The Battelle Columbus Laboratories, under contract to the Department of Energy (DOE), prepared a report regarding item 4c (see appendix, item 1). This document has been referred to DOE for disposition and direct response to you. The NRC has no information regarding item 4d and requests that you contact the Department of Defense for information.

With regard to item 4(e), a copy of the Final Environmental Statement related to the operation of Shoreham Nuclear Power Station Unit 1, dated October 1977, (NUREG-0286) is enclosed.

With regard to item 5, Indian Point Unit 1 was shut down on October 31, 1974. All fuel has been unloaded and no decision on future operation has been made. See the page on Indian Point 1 taken from the "Operating Units Status Report" of August 1979, NUREG-0020, Vol. 3, No. 8 (appendix, item 3).

With regard to item 6, see appendix items 4-6. Such reports are sent monthly to the NRC Public Document Room (PDR) located at 1717 H Street, N.W., Washington, DC 20555 and the Local Public Document Room (LPDR), the White Plains Public Library, 100 Martine Avenue, White Plains, NY 10601. 
