Subject: Combined Inspection 50-317/79-08 and 50-318/79-07

This refers to the inspection conducted by Mr. L. Thonus of this office on May 21-25, 1979 at the Calvert Cliffs Nuclear Power Station, Units 1 and 2, Lusby, Maryland of activities authorized by NRC License Nos. DPR-53 and DPR-69 and to the discussions of our findings held by Mr. Thonus with Mr. L. B. Russell of your staff at the conclusion of the inspection, and to a subsequent telephone discussion between Mr. Thonus of my staff and Mr. A. J. Kaupa of your staff on May 30, 1979 and Mr. L. B. Russell of your staff on June 14, 1979.

Areas examined during this inspection are described in the Office of Inspection and Enforcement Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, measurements made by the inspector, and observations by the inspector.

In addition our inspector reviewed the additional information provided in your response letter (not dated) to Item B contained in Appendix A, Notice of Violation, dated September 13, 1978.

Based on inspector review of the additional information supplied, we hereby withdraw the item of noncompliance identified as Item B contained in the above Notice of Violation, and accordingly this will be reflected in our records.

Based on the results of this inspection, it appears that one of your activities was not conducted in full compliance with NRC requirements, as set forth in the Notice of Violation, enclosed herewith as Appendix A. This item of noncompliance has been categorized into the levels as described in our correspondence to you dated December 31, 1974. This notice is sent to you pursuant to the provisions of Section 2.201 of the NRC's "Rules of Practice", Part 2, Title 10, Code of Federal Regulations. Section 2.201 requires you to submit to this office,

within twenty (20) days of your receipt of this notice, a written statement or explanation in reply including: (1) corrective steps which have been taken by you and the results achieved; (2) corrective steps which will be taken to avoid further items of noncompliance; and (3) the date when full compliance will be achieved.

Item number A shown in the Notice of Violation enclosed with this letter, is a recurrent or uncorrected item. In your response please give this matter your particular attention.

In accordance with Section 2.790 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, a copy of this letter and the enclosures will be placed in the NRC's Public Document Room. If this report contains any information that you (or your contractor) believe to be proprietary, it is necessary that you make a written application within 20 days to this office to withhold such information from public disclosure. Any such application must be accompanied by an affidavit executed by the owner of the information, which identifies the document or part sought to be withheld, and which contains a statement of reasons which addresses with specificity the items which will be considered by the Commission as listed in subparagraph (b)(4) of Section 2.790. The information sought to be withheld shall be incorporated as far as possible into a separate part of the affidavit. If we do not hear from you in this regard within the specified period, the report will be placed in the Public Document Room.

Should you have any questions concerning this inspection, we will be pleased to discuss them with you.
