This letter is to inform you that during the recent TMI-1 refueling outage, Met-Ed replaced the pump shafts on both DH-PlA and DH-PlB. The replacement shafts have rounded keyways and the appropriate material certification and heat treatment documentation. Both pumps have successfully passed their post-maintenance Inservice Inspection Tests and are fully operational and running smoothly.

In view of having replaced the pump shafts, Met-Ed feels that there is no remaining commitment to perform periodic ultrasonic testing and vibration measurements, and as such, Met-Ed intends to do only the testing required by ASME Section XI.
