Intervenors have moved for the Board's acceptance of Intervenors' withdrawal from this proceeding, the Board accordingly
accepts the withdrawal of Intervenors as a party to this

Therefore, it is ORDERED that the proceeding before this Board noticed in the Commission's Notice of Hearing in this proceeding dated February 26, 1973, be, and it hereby is, dismissed.
