I spoke with the Exelon Fleet Project Manager in NRR/DORL, who indicated that placing this email into ADAMS would provide sufficient documentation of Exelon's notification of the NRC regarding the opportunity to observe these drills per Exelon's commitment documented in respective NRC safety evaluations.

At this time, NSIR/DPR (NRC HQ) plans to observe the following drills, and will coordinate our with observation with FEMA and Region I:

- August 27, 2019 TMI Decommissioning PSEP Demonstration Drill, and
- November 15, 2019 Calvert Cliffs / Peach Bottom Dual Site Demonstration for the Calvert EOF move to Coatesville.

Mike Norris of my staff has the lead in coordinating NRC observation of the above drills, and requests that you forward him a copy of the narrative summary/timeline for these drills, which he will place in ADAMS as "non-public" for drill scenario confidentiality purposes. Mike will work through respective NRR/DORL Project Manager to arrange a conference call prior to these drills to discuss the scenario scope/extent of play and coordinate logistics.

I will inform FEMA HQ and FEMA Region III RAC Chair of the August 27 and November 15 drill dates and request confirmation as to FEMA's intent to observe these drills.

Finally, NSIR/DPR (NRC HQ) does <u>not</u> plan on observing the ERO minimum staffing drills listed below for Limerick, Peach Bottom and LaSalle Stations, but I am "cc'ing" Region I and III EP Branch Chiefs for their awareness.
