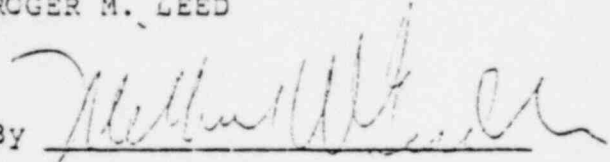
In accordance with 10 CFR §2.740(b) and 10 CFR §2.741, please answer the following Interrogatories and respond to the accompanying Requests for Production.
