SUBJECT: BOMB TEREAT

At 1:47 p.m. on October 19, 1979, the Daniel International Corporation telephone switchboard operator received a bomb threat call from the on site extension No. 140. This is the second bomb threat received from this extension. The voice was calm and that of a young man approximately 30 to 40 years old who stated, "There is a bomb in the Aux Building." He then hung up.

An evacuation and search of the Auxiliary Building was immediately started. No bomb was found. No site evacuation was conducted.

The Sheriff of Coffey County, Kansas City FBI and ATF were notified. The LAT and office of Commissioner Eendrie and Kennedy were notified by telephone on October 19, 1979.

No press release was made or planned by the licensee or NRC.

The site construction progress is currently reported at 37% complete. There is no SNM on site.

This Preliminary Notification is issued for information only and no further action by IE is anticipated. Region IV, Arlington, Texas, received notification of this occurrence by relephone from the KG&E Security Officer at 2:10 p.z. on October 19, 1979,
