RESOLUTION

We, The Governing Body of Londonderry Township, Dauphin County, Pennsylvania hereinafter list certain stipulations as prerequisites to future operations of the Nuclear Industrial Facility located within our Township (i. e. Three Mile Island).

In recognition of the fact that all decisions regarding the operation of aforementioned facility are pre-empted by the Federal Government agency(ies) we address our resolution and its stipulations to:

1. The President of the United States of America
2. The Congress of the United States of America
3. The President's Commission on Three Mile Island
4. The Commissioners of the Nuclear Regulatory Commission
5. The Governor of the Commonwealth of Pennsylvania
6. The President of General Public Utilities

Be it resolved that the Industrial Plant commonly known as TMI-Unit One and Two should not be reopened until:

The President's Commission

1. The President's Commission on Three Mile Island has rendered its final report and recommendations.

Safe Operations

2. Safe Operation is assured by having:
 - a. Fail safe mechanical back-up
 - b. Continuing education and evaluation of personnel

c. A qualified Nuclear Engineer on duty 24 hours a day

d. Nuclear Regulatory Commission on site supervision

Security

3. The Physical Security of the Plant sites be improved to preclude any possibility of damage caused by sabotage, covert military action or fanatical groups.

4. Personnel working within the area carry appropriate Federal Security Clearance.

Waste Disposal

5. The Safe Containment, Disposal or Removal of all present radioactive waste from Londonderry Township is accomplished and plans are devised for safe transportation of any future waste.

Communications and Evacuation


6. An effective Communication Network is established to notify the Public and appropriate Governmental Emergency Response Personnel in the event of either a malfunction or planned radioactive release that may effect the safety and health of Londonderry Township Citizens.

7. An Evacuation Plan is accomplished, published and coordinated with Emergency State Response Personnel and a standard evacuation signal is developed.


Financial Responsibility

8. The Citizens of Londonderry Township can be guaranteed full recovery of financial loss due to a Nuclear Accident.
