Dear Dr. Tan:

In response to the referenced letter for information on the LaSalle County Station, representatives of Commonwealth Edison Company have discussed this request with the NRC LaSalle County Project Manager. It was determined that this information is not required for the LaSalle County Station operating license review. In view of these considerations, Commonwealth Edison representatives have advised me they cannot commit the manpower required to respond to your request.

A similar request was made to the Zimmer Station at a meeting on December 5, 1979. Subsequent review by representatives of Cincinnati Gas & Electric Company showed that it was not appropriate for the NRC to retain consultants to review the Zimmer project for application of SRSS to structural design. Since they have not requested the use of SRSS for structural application on the Zimmer Station, they therefore do not feel that it is reasonable to ask them to undertake expenditures of both financial and technical resources to this effort.

The Mark II Owners Group, including Commonwealth Edison Company and Cincinnati Gas & Electric Company, have accepted the NRC criteria established in NUREG-0487 for combining responses using absolute sums for containment structures. Therefore, your investigation is also beyond the scope of current Mark II Owners Group programs. Since NRC approval is still pending on Mark II Owners use of SRSS for combining responses for design of systems, components and supports, it would be more prudent to resolve this outstanding concern with all its ramifications first before embarking on a new application area.


