Enclosed is Amendment No. 112 to your NRC Material License No. 21-12275-02 in accordance with your request.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

In preparing this amendment, we added and changed the names of your facilities in Condition Nos. 10.A. and 10.B, as appropriate. We also corrected the spelling of "Capital" from "Capitol" in Condition No. 10.B., which was apparently an error introduced in Amendment No. 111 by another reviewer.

We apologize for this error and for any inconvenience it may have caused you.

We also continued the combination of former Condition Nos. 10.B. and 10.C., as they appeared on Amendment No. 110, by making them into one Condition No. 10.B. This is logical because both facilities are authorized for the exact same materials. Amendment No. 111 combined these sub-conditions initially.

This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions.

Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.


