This is in reference to the Surety Bond rider signed June 10, 2019, which was received in our office on June 16, 2019. This rider amends the surety bond to the new amount of cost estimate for decommissioning financial assurance accepted in our letter dated April 10, 2019, and the new company name accepted in Amendment 23 issued December 13, 2018. As we stated in the April 10 letter, because of the change of your name and the amount of the cost estimate, we also need a new Certificate of Financial Assurance (CFA), and an amended Standby Trust Agreement (STA) with an amended Schedule A to the STA. We have opened a licensing action on receiving the Surety Bond rider, and need the other documents to complete the update of your financial assurance.


