STATION SECURITY PROCEDURE 1005.12

INTERFACE WITH VISITORS DURING A RADIATION EMERGENCY

1.0 PURPOSE

This procedure details the action to be taken, and the control imposed by the Site Protection Officers (SPOs) in processing visitors during a radiation emergency.

1.1 Scope

This procedure deals exclusively with visitors who are in the area between the North gate entrance and the Service Building who are enroute to or from the nuclear station when a radiation emergency alarm is sounded.

3.0 PROCEDURE

When a Radiation Emergency Alarm or verbal notification is received by the North Gate SPO, the SPO shall take the following action:

- 3.1 Immediately close the North gate to personnel entrance and exit from the site. The Shift Supervisor may authorize entrance or egress from the site.
- 3.2 Immediately contact all visitors present in the area between the North gate entrance and the Service Building and take the following action.
  - a. Instruct all visitors to proceed to the North Assembly Area (Parking lot north of the Service Building).
  - b. Arrange for release of visitors after they have been monitored for possible contamination and the prevailing emergency conditions are terminated.

3.3 After all personnel have been accounted for, and the radiation emergency has been terminated the North Gate will be reactivated and processing of authorized visitors, employees, etc. will be resumed.
