Gentlemen:

This refers to the inspection conducted by W. H. Miller, Jr. of this office on April 16-20, 1979 of activities authorized by NRC License Nos. DPR-71 and DPR-62 for the Brunswick Steam Electric Plant facility, Units 1 and 2, and to the discussion of our findings held with A. C. Tollison, Jr. at the conclusion of the inspection.

Areas examined during the inspection and our findings are discussed in the enclosed inspection report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Two new unresolved items resulted from this inspection and are discussed in the enclosed report. These items will be examined during subsequent inspections.

During the inspection, it was found that certain activities under your license appear to be in noncompliance with NRC requirements. Two items and references to pertinent requirements are listed in the Notice of Violation enclosed herewith as Appendix A. This notice is sent to you pursuant to the provisions of Section 2.201 of the NRC's "Rules of Practice", Part 2, Title 10, Code of Federal Regulations. Section 2.201 requires you to submit to this office, within 20 days of your receipt of this notice, a written statement or explanation in reply including: (1) corrective steps which have been taken by you, and the results achieved; (2) corrective steps which will be taken to avoid further noncompliance; and (3) the date when full compliance will be achieved.

During the inspection it was found that certain activities under your license appear to deviate from commitments to the Commission and have safety significance. This item is identified in the Notice of Deviation enclosed herewith as Appendix B. Please provide us in writing within 20 days of your receipt of this letter your comments including a description of corrective actions that have been or will be taken, corrective actions which will be taken to avoid further deviations, and the date corrective actions were or will be completed.


