Dear Mr. Brady:

On July 25, 2019, the U.S. Nuclear Regulatory Commission (NRC) issued White Sands Missile Range security violations identified during a routine inspection performed on June 25-26, 2019, at your facilities at White Sands Missile Range, New Mexico. The NRC Inspection Report 030-09345/2019-001 with enclosed Notice of Violation required you to respond in writing within 30 days. You responded with a non-publicly available letter dated August 12, 2019.

After reviewing the information which you provided in your response to the Notice of Violation, we have concluded that your completed and proposed actions appear to adequately address the regulatory non-compliances described in the Notice of Violation. We will review your implementation of these corrective actions during a future inspection to determine whether full compliance has been restored and whether compliance will be maintained.
