## Ladies and Gentlemen:

Pursuant to 10 CFR 52.99(c)(3), Southern Nuclear Operating Company (SNC), the licensee for Vogtle Electric Generating Plant (VEGP) Unit 3 Combined License (COL) Number NPF-91, hereby notifies the NRC that as of January XX, 2020, Inspection, Test, Analysis, and Acceptance Criteria (ITAAC) items listed in Enclosure 1 will not be completed XXX(315)-days prior to initial fuel load currently scheduled for XX, 2020. Enclosure 1 lists all VEGP Unit 3 Appendix C ITAAC for which required inspections, tests, or analyses have not been performed or have been only partially completed along with the corresponding UIN. SECY-15-0010 allows for the notice of intended operation to be published up to 75 days earlier than the 210 days before scheduled fuel load based on SNC's voluntary early submission of its UINs. SNC is submitting this Notice of Uncompleted ITAAC XXX(315)-days prior to initial fuel load in support of the publication of the notice of intended operation 285 days prior to scheduled fuel load.

This notification is informed by the guidance described in NEI 08-01, *Industry Guideline for the ITAAC Closure Process Under 10 CFR Part 52*, which was endorsed by the NRC in Regulatory Guide 1.215. In accordance with NEI 08-01, this notification includes ITAAC for which required inspections, tests, or analyses have not been performed or have been only partially completed. All ITAAC will be fully completed and all Section 52.99(c)(1) ITAAC Closure Notifications will be submitted to NRC to support the Commission finding that all acceptance criteria are met prior to plant operation, as required by 10 CFR 52.103(g).

This letter contains no new NRC regulatory commitments.

Pursuant to 10 CFR 52.99(c)(4), and in accordance with Vogtle Electric Generating Plant (VEGP) Unit 3 Combined License (COL) NPF-91 condition 2.D.(2)(d), Southern Nuclear Operating Company (SNC) hereby notifies the NRC that all of the inspections, tests, analyses and acceptance criteria (ITAAC) in VEGP Unit 3 COL Appendix C have been successfully completed.

ITAAC Closure Notifications have been submitted to the NRC for each ITAAC in VEGP Unit 3 COL Appendix C in accordance with 10 CFR 52.99(c)(1). All of the ITAAC Closure Notifications are substantiated by ITAAC Completion packages, which include the documentation (tests, reports, completed procedures, completed analyses, etc.) that support the ITAAC determination bases.
