NRC Atomic Safety and Licensing Board to Hold Hearing, Take Limited Appearance Statements on Seabrook License Amendment

An Atomic Safety and Licensing Board will hold an evidentiary hearing Sept. 24-27 in Newburyport, Mass., to consider a challenge to an amendment to the Seabrook nuclear power plant's operating license, regarding concrete degradation caused by the alkali-silica reaction.

The hearing is scheduled to begin at 9:30 a.m., on Sept. 24 at the Newburyport City Hall Auditorium, 60 Pleasant St., in Newburyport. It will continue each day until 5:30 p.m., on Sept. 27, unless the board finishes earlier.

The ASLB is the Nuclear Regulatory Commission's independent body charged with conducting adjudicatory hearings and deciding legal challenges to the agency's licensing and enforcement actions. NextEra Seabrook operates the single-reactor Seabrook plant, 13 miles south of Portsmouth, N.H.

An intervenor, C-10 Research and Education Foundation, filed 10 proposed contentions regarding a license amendment NextEra Seabrook requested for analyzing the impact of concrete degradation caused by the alkali-silica reaction. The ASLB heard oral arguments in June 2017 on the admissibility of the contentions, and on Oct. 6, 2017, granted a hearing on five contentions, which were consolidated into one. That contention claims that NextEra's large-scale concrete testing program yielded data that are not representative of the reaction's progression at Seabrook Unit 1, and that the resulting monitoring, acceptance criteria and inspection intervals are inadequate. The hearing will focus on the merits of this contention.

The evidentiary hearing is open to the public. The board will only hear testimony and legal arguments from witnesses and representatives for C-10, the NRC, and NextEra. No members of the public will be heard during this proceeding. Security measures may be employed at the entrance to the facility, including searches of hand-carried items such as briefcases or backpacks. No signs, banners, posters, or other displays will be permitted at the hearing. In addition, some of the evidence submitted in this proceeding is subject to a protective order, and it may therefore be necessary for the Board to close the evidentiary hearing to the public when protected information is being discussed.

Members of the public may, however, submit oral or written "limited appearance statements" regarding the hearing. These statements, which may be considered by the judges, do not constitute testimony or evidence. Oral statements may be given on Sept. 23, from 6-8 p.m., at the

Newburyport City Hall Auditorium, 60 Pleasant St. in Newburyport. The hearing's security measures and prohibition on public displays also apply to the oral limited appearance session.

If all speakers at the session have made a presentation, the Board reserves the right to terminate the session prior to 8 p.m. Each speaker will be allowed five minutes, but that time may be further limited depending on the number of requests to make an oral statement. Those who provide a written request to make an oral statement will be given priority at the session.
