Purpose:

To revise a previous staff paper (SECY-78-613) to incorporate staff comments of the Office of Policy Evaluation and the Office of the General Counsel.

Category:

Routine matter requiring Commission consideration.

Value Impact Statement: None required.

Discussion:

The proposed Federal Register natice (Enclosure 3 of SECY-78-613) has been revised to incorporate the Office of Policy Evaluation and the Office of the General Counsel staff comments. The NRC staff position has been expanded to address the legal arguments raised by NRDC to require a mon torium on licensing of new or enlarged burial sites (pp. 18-19). The staff position has been expanded to address the legal arguments raised by NRDC to require a Generic Environmental Impact Statement (GEIS) on low-level waste disposal (pp. 26-27). A discussion of the Environmental Impact Statement (EIS) planned by the staff to support the proposed low-level waste management regulation has been included to support the staff's position that the NRC regulatory development effort will obviate the need for a GEIS (pp. 27-28). A discussion of the planned EIS on the proposed low-level waste management was deleted from the background section of the notice to eliminate repetition (p. 13).
