SUPPLEMENTAL AGREEMENT BETWEEN

CORNELL UNIVERSITY

AND

THE U. S. NUCLEAR REGULATORY COMMISSION

THIS SUPPLEMENTAL AGREEMENT, effective the 1st day of October , 1978, by and between the UNITED STATES OF AMERICA (hereinafter referred to as the "Government"), as represented by the UNITED STATES NUCLEAR REGULATORY COMMISSION (hereinafter referred to as the "Commission"), and CORNELL UNIVERSITY

(hereinafter referred to as the "Contractor"),

WITNESSETH THAT:

WHEREAS, the parties desire to modify Contract No. NRC- 04-76-234 as hereinafter provided, and this supplemental agreement is authorized by law, including the Energy Reorganization Act of 1974, as amended, and the Atomic Energy Act of 1954, as amended.

NOW, THEREFORE, said contract is hereby modified as follows:

- Appendix A, attached to this supplemental agreement and made a part hereof, provides for the research to be performed by the Contractor during the contract period specified therein.
- In Article II The Period of Performance, the date "December 31, 1979" is substituted for the date "September 30, 1978".
- In Article III Consideration, the sum "\$277,001.00" is substituted for the sum "\$ 177,001.00.
